3. Type of Allocation of Quota Places:

The quota places are allocated to the NOC(s) qualified for the team events by number (1 team and 2 singles) and to the athlete(s) for the remaining singles quotas and for the Mixed Doubles event.

C. ATHLETE ELIGIBILITY

All athletes must comply with the provisions of the Olympic Charter currently in force, including but not limited to, Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions). Only those athletes who have complied with the Olympic Charter may participate in the Olympic Games.

Additional IF Requirements:

Qualification is open to all athletes selected by their NF and approved by their NOC to take part in the Olympic Games. To be eligible to participate in the Olympic Games Tokyo 2020, all athletes must:

HOST COUNTRY PLACES

The Host Country is guaranteed

- One (1) Team
- Two (2) Men's Singles quota places and Two (2) Women's Singles quota places
- One (1) Mixed Doubles pair

TRIPARTITE COMMISSION INVITATION PLACES

One (1) men's singles and one (1) women's singles Tripartite Commission Invitation Places are made available to eligible NOCs at the Olympic Games Tokyo 2020.

Tripartite Commission athletes must have appeared on any ITTF Ranking list from 1st July 2019 to 30th June 2021.

On 14 October 2019, the International Olympic Committee will invite all eligible NOCs to submit their requests for Tripartite Commission Invitation Places. The deadline for NOCs to submit their requests is 15 January 2020. The Tripartite Commission will confirm, in writing, the allocation of invitation places to the relevant NOCs after the end of the qualification period for the concerned sport.

Detailed information on Tripartite Invitation places is contained in the “*Games of the XXXII Olympiad, Tokyo 2020 - Olympic Games Tripartite Commission Invitation Places - Allocation Procedure and Regulations*”.

E. CONFIRMATION PROCESS FOR QUOTA PLACES

Following each Continental or World Qualification event, or for any ranking selection, the ITTF will publish the results on its website (www.ittf.com) and inform the respective NOCs of their qualified quota places. The NOCs will then have fifteen (15) days to confirm if they wish to use these quota places, as detailed in paragraph H. **Qualification Timeline.**

Following the ITTF Olympic Singles Qualification Ranking list selection; ITTF will confirm in writing no later than 5 June 2021 to NOCs/NFs the full list of names of all qualified athletes and teams.

By 30 June 2021, the ITTF will publish the final confirmed list of all qualified athletes and teams.

F. REALLOCATION OF UNUSED QUOTA PLACES

REALLOCATION OF UNUSED QUALIFICATION PLACES

1. Continental Qualification Tournament (Teams/Singles/Mixed Doubles)

Any unused quota places obtained at the Continental Qualification Tournaments will be reallocated to the next best-placed eligible team / athlete of the same gender or mixed doubles pair, not yet qualified, from the respective Continental Qualification Tournament.

If the singles / mixed doubles continental quotas are not attained by 15th May 2021, the remaining quota places will be reallocated to the next best-ranked eligible athlete of the same gender or mixed double pair of the same continent on the ITTF Olympic Singles/Mixed Doubles Qualification Ranking list of May 2021.

If the team continental quotas are not attained by 15th May 2021, the remaining quota places will be reallocated to the next best-ranked eligible NOC team of the same gender of the same continent on the ITTF Olympic Teams Qualification Ranking list of February 2020.

2. Mixed Doubles (World Tour Grand Finals 2019 / World Tour 2020 / WTT 2021)

Any unused quota places obtained at the World Tour Grand Finals / World Tour 2020 / WTT 2021 tournaments will be reallocated to the next best-placed eligible mixed doubles pair, not yet qualified, from the Olympic Mixed Doubles Qualification Ranking list published the month after the last qualification tournament (World Tour 2020 / WTT 2021) takes place.

Any qualified athletes in Mixed Doubles will be part of the team composition if their NOC has qualified a Men's and/or Women's team.

3. World Qualification Tournament (Teams/Singles)

Any unused quota places obtained at the World Teams/Singles Qualification Tournaments will be reallocated to the next best-placed eligible team / athlete of the same gender, not yet qualified, from the respective World Team/Singles Qualification Tournament.

If the World Team Qualification quotas are not attained by 15th February 2020, the remaining quota places will be reallocated to the next best-ranked eligible Team of the same gender on the ITTF Olympic Teams Ranking list of February 2020.

If the World Qualification Singles quotas are not filled by 15th June 2021, the remaining quota places will be reallocated to the next best-ranked eligible athlete of the same gender on the ITTF Olympic Singles Qualification Ranking list of June 2021.

4. Unallocated quotas due to events cancellations.

Any unused quota places due to the cancellation of any of the qualification tournaments will be reallocated to the next best-ranked eligible pair or athlete, not yet qualified, on the ITTF Olympic Mixed Doubles / Singles Qualification Ranking list of May 2021 (Mixed Doubles) and June 2021 (Singles).

5. ITTF Olympic Singles Qualification Ranking List

Any unused quota place obtained through the ITTF Olympic Singles Qualification Ranking list will be reallocated to the next best-ranked eligible athlete of the same gender, not yet qualified, on the ITTF Olympic Singles Qualification Ranking list of June 2021.

REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused Host Country Place(s) will be reallocated to the next best-ranked eligible team/athlete/pair on the June 2021 ITTF Olympic Team/Singles/Mixed Doubles Qualification Ranking list.

REALLOCATION OF UNUSED TRIPARTITE COMMISSION INVITATION PLACES

If the Tripartite Commission is not able to allocate a Tripartite Commission Invitation Place, it will be reallocated to the next eligible best ranked eligible athlete on the June 2021 ITTF Olympic Singles Qualification Ranking list.

G. GENERAL PRINCIPLES REGARDING THE USE OF P ALTERNATE ATHLETES

P ALTERNATE ATHLETES

P alternate athletes are non-competing athletes and are not included within the athletes' quota as described in Paragraph **B. Athletes Quota**. More detailed information about entitlements and quotas can be found in the '*Accreditation at the Olympic Games – Users Guide*'. P alternate athletes can only become competing athletes as per the conditions outlined in the '*IOC/Tokyo 2020 Late Athlete Replacement policy*'.

Eligibility:

P alternate athletes must comply with the same eligibility rules as competing athletes as described in above paragraph **C. Athlete Eligibility**.

Each qualified team is entitled to one (1) P alternate athlete.
